## **DEALER TRADE LICENCE GUIDELINES & APPLICATION**

### **PURPOSE**

In the interest of promoting the sport of karting to potential newcomers the Australian Karting Association (AKA) is providing a scheme which allows kart dealers who successfully apply for a Dealer Trade Licence (DTL) to offer test drives under controlled conditions and guidelines aimed at ensuring a safe and responsible environment and experience.

### **GUIDELINES**

Only dealers who have successfully applied for a DTL are allowed to use AKA affiliated tracks for the purpose of providing test drives to non licensed persons.

Only dealers with registered business names associated with karting and current operational businesses within the karting industry are eligible to apply.

Dealers are required to hold a current Public & Products liability insurance cover with a minimum policy limit of \$10,000,000 and certificate of currency is to be presented with their application form.

A Log book record of a type defined by the AKA must be maintained by the dealer at all times with records being made available by the dealer to the AKA within 7 days of the AKA, or it's insurer, making a request.

Unlicensed drivers (UD) must sign a waiver form of a type defined by the AKA. The waiver forms must be filed by the dealer together with the log book records

A UD is eligible to complete a maximum of 50 laps of the track per day.

Karts used must clearly display a L Plate indicating learner.

UD's must wear all appropriate safety clothing as required by the AKA rules.

The dealer is responsible for providing a briefing to all UD's before they enter the track including the following:

- Correct entry to the track
- Direction of the track including clarifying any possible confusion that is possible with dummy grids and or track entry lanes
- Observance of other karts particularly faster karts
- The use of necessary hand signals whilst driving on the track , if a spin occurs and when exiting the track
- Correct re-entry to the track should the UD go off the track at any point

AKA licensed drivers are not permitted on the track at the same time as UD and only a maximum of three karts are to be on the track at any one time and they are to be at staggered intervals around the track.

## **Age and Kart Requirements**

### **7-10 years of age**

These drivers are restricted to karts complying with the AKA regulations for the Midget class.

### **11-12 years of age**

These drivers are restricted to karts complying to the AKA regulations for the Midget or Rookie class.

### **13-16 years of age**

These drivers are restricted to karts complying to the AKA regulations for the Junior National class.

### **16 years and over**

These drivers are restricted to karts complying with the National, Clubman or Restricted 125 category regulations as outlined in the AKA Manual.

## **General Information**

Holders of DTL acknowledge that failure to abide by these guidelines at all times could render them responsible should any accidents , incidents or injuries occur

Dealers must have their DTL on them at all times and be fully prepared to present it to a club official who makes a reasonable request.

The cost of the DTL is \$250 including gst per annum. This will be invoiced initially on acceptance of the application by the AKA and then annually in approximately January of each year.

No pro rata dates/payments will apply , the initial invoice will only cover to 31st December of the year of application.
